CUSTOMER CONTRACT REQUIREMENTS

252.227-7030 Technical Data -- Withholding of Payment (MAR 2000). In this clause, "Government" and "Contracting Officer" shall mean Buyer. This clause applies only if the delivery of technical data is required under this contract.

252.227-7037 Validation of Restrictive Markings on Technical Data (SEP 1999). This clause applies only if the delivery of data is required by this contract.

252.228-7005 Accident Reporting and Investigation Involving Aircraft, Missiles, and Space Launch Vehicles (DEC 1991).

252.231-7000 Supplemental Cost Principles (DEC 1991).

252.243-7001 Pricing of Contract Modifications (DEC 1991).

252.244-7000 Subcontracts for Commercial Items and Commercial Components (DoD Contracts) (JUN 2012).

Huntington Beach Procurement Clause:

A. COUNTERFEIT PARTS

- (a) "Counterfeit work" means work that is or contains items deliberately misrepresented as having been designed and/or procured under an approved system or acceptable method. The term also includes approved work that has reached a design life limit or has been damaged beyond possible repair, but are altered and deliberately misrepresented as acceptable.
- (b) Seller shall only procure products to be delivered or incorporated as work to Buyer directly from the original component manufacturer (OCM)/original equipment manufacturer (OEM), or through an OCM/OEM authorized distributor chain. Work shall not be acquired from independent distributors or brokers unless approved in advance in writing by Buyer.

- (e) Seller shall include the following phrase in all subcontracts issued in support of this order: "Seller shall procure all electrical, electronic and electro-mechanical parts delivered to Buyer and/or used in the manufacture of deliverable Buyer hardware directly from the original manufacturer of the part or the original manufacturer's authorized distributor only (e.g., licensed or franchised distributor)."

Records Retention

The following data retention requirements override any other data retention requirement contained within P.O. Note 5831, the SOR, or elsewhere within P.O. 4100748387 contract:

- I. Storage and protection of data/documentation. The Seller shall retain and maintain a copy of the following data/documentation:
- (a) All Applicable TDP Elements as defined in MIL-STD-31000
- (b) All "As designed" Baseline Listings of the TDP
- (c) All TDP Change History to include RFDs/RFWs
- (d) All product "As Built" data (historical logbooks)

II. This I. (a) (b) (c) and (d) data/documentation shall be maintained for 10 years.
