CUSTOMER CONTRACT REQUIREMENTS

The following customer contract requirements apply to this Contract to the extent indicated below. If this Contract is for the procurement of commercial products and/or commercial services under a Government prime contract, as defined in FAR Part 2.101, Section 3 replaces the requirements of Sections 1 and 2 below. Please note, the requirements below are developed in accordance with Buyer's prime contract and are not modified by Buyer for each individual Seller or statement of work. Seller will remain at all times responsible for providing to any government agency, Buyer, or Buyer's customer, evidence of compliance with the requirements herein or that such requirements are not applicable to the extent satisfactory to the requesting party.

- **1. FAR Clauses** The following contract clauses are incorporated by reference from the Federal Acquisition Regulation and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller.
 - **52.203-6 Restrictions on Subcontractor Sales to the Government** (JUN 2020). This clause applies if the contract exceeds the simplified acquisition threshold, as defined in the Federal Acquisition Regulation 2.101 on the date of subcontract award.
 - **52.203-7 Anti-Kickback Procedures** (JUN 2020). Buyer may withhold from sums owed Seller the amount of any kickback paid by Seller or its subcontractors at any tier if (a) the Contracting Officer so directs, or (b) the Contracting Officer has offset the amount of such kickback against money owed Buyer under the prime contract. This clause, excluding subparagraph (c)(1), applies if this contract exceeds the threshold specified in FAR 3.502-3(i) on the date of subcontract award.
 - **52.203-8 Cancellation, Rescission, and Recovery of Funds for Illegal or Improper Activity** (MAY 2014). This clause applies to this contract if the Seller, its employees, officers, directors or agents participated personally and substantially in any part of the preparation of a proposal for this contract. The Seller shall indemnify Buyer for any and all losses suffered by the Buyer due to violations of the Act (as set forth in this clause) by Seller or its subcontractors at any tier.
 - **52.203-10 Price or Fee Adjustment for Illegal or Improper Activity** (MAY 2014). This clause applies only if this contract exceeds (i) \$100,000 if included in Buyer's customer RFP or customer contract issued before October 1, 2010 or (ii) \$150,000 if included in Buyer's customer RFP issued on or after October 1, 2010, or if the prime contract was issued prior to October 1, 2010 but was amended after October 1, 2010 to increase the Simplified Acquisition Threshold. If the Government reduces Buyer's price or fee for violations of the Act by Seller or its subcontractors at any tier, Buyer may withhold from sums owed Seller the amount of the reduction.
 - **52.203-11 Certification and Disclosure Regarding Payments to Influence Certain Federal Transactions** (SEP 2007). This clause applies only if this contract exceeds (i) \$100,000 if included in Buyer's customer RFP or customer contract issued before October 1, 2010 or (ii) \$150,000 if included in Buyer's customer RFP issued on or after October 1, 2010, or if the prime contract was issued prior to October 1, 2010 but was amended after October 1, 2010 to increase the Simplified Acquisition Threshold.
 - **52.203-12 Limitation on Payments to Influence Certain Federal Transactions** (JUN 2020). This clause applies if this contract exceeds the threshold specified in FAR 3.808 on the date of subcontract award. Paragraph (g)(2) is modified to read as follows: "(g)(2) Seller will promptly submit any disclosure required (with written notice to Boeing) directly to the PCO for the prime contract. Boeing will identify the cognizant Government PCO at Seller's request. Each subcontractor certification will be retained in the subcontract file of the awarding contractor."
 - **52.203-13 Contractor Code of Business Ethics and Conduct** (NOV 2021). This clause applies if this contract exceeds the threshold specified in FAR 3.1004 (a) on the date of contract award and has a performance period of more than 120 days.

This clause applies if this contract exceeds the threshold specified in Federal Acquisition Regulation 3.1004 (b)(1) on the date of subcontract award, except if the contract is for the acquisition of a commercial product or commercial service, or is performed entirely outside the United States.

- **52.203-16 Preventing Personal Conflicts of Interest** (JUN 2020). This clause applies if the contract exceeds the simplified acquisition threshold, as defined in Federal Acquisition Regulation 2.101 on the date of contract award, where Seller's employees will perform acquisition functions closely associated with inherently governmental functions, as defined in paragraph (a) of the clause. The term "Contracting Officer" means "Buyer." In paragraph (a), under the definition of "Covered employee", in subparagraph (1) "Contractor" means "Seller" and in subparagraph (2), the term "subcontractor" means "Seller" and "Contractor" means "Buyer" if Seller is a self-employed individual.
- **52.203-17** Contractor Employee Whistleblower Rights and Requirement to Inform Employees of Whistleblower Rights (APR 2014). This clause applies only if this contract exceeds simplified acquisition threshold.
- **52.203-19** Prohibition on Requiring Certain Internal Confidentiality Agreements or Statements (JAN 2017).
- **52.204-2 Security Requirements** (MAR 2021). The reference to the Changes clause means the changes clause of this Contract. This clause applies only if the Contract involves access to classified material.
- **52.204-9 Personal Identity Verification of Contractor Personnel.** (JAN 2011). This clause applies only if performance under this contract requires Seller to have routine physical access to a Federally-controlled facility and/or routine access to a Federally-controlled information system.
- **52.204-13 System for Award Management Maintenance.** (OCT 2018).
- **52.204-21** Basic Safeguarding of Covered Information Systems (JUN 2016).
- **52.204-23** Prohibition on Contracting for Hardware, Software, and Services Developed or Provided by Kaspersky Lab and Other Covered Entities (JUL 2018). In paragraph (c)(1), the term "Government" means "Government or Buyer" and the term "Contracting Officer" means "Buyer." All reporting required by paragraph (c) shall be reported through Buyer. Seller shall report the information in paragraph (c)(2) to Buyer.
- **52.204-25** Prohibition on Contracting for Certain Telecommunications and Video Surveillance Services or Equipment (NOV 2021).

Paragraph (b)(2) is deleted. Paragraph (d)(1) is deleted and replaced with the following: "In the event Seller identifies covered telecommunications equipment or services used as a substantial or essential component of any system, or as critical technology as part of any system, during contract performance, or Seller is notified of such by a subcontractor at any tier or any other source, Seller shall report the information in paragraph (d)(2) of this clause via email to Buyer's Authorized Procurement Representative, with the required information in the body of the email.

- **52.204-27 Prohibition on a ByteDance Covered Application** (JUN 2023). In paragraph (b), if an exception has been granted by the Contracting Officer, notice shall be provided to Seller through Buyer.
- **52.209-6** Protecting the Government's Interests When Subcontracting With Contractors Debarred, Suspended or Proposed for Debarment (NOV 2021). This clause applies if the contract exceeds the threshold specified in FAR 9.405-2(b) on the date of subcontract award. Seller agrees it is not debarred, suspended, or proposed for debarment by the Federal Government. Seller shall disclose to Buyer, in writing, whether as of the time of award of this contract, Seller or its principals is or is not debarred, suspended, or proposed for debarment by the Federal Government. This clause does not apply if the contract is for commercially available off-the shelf items.
- **52.211-5 Material Requirements** (AUG 2000). Any notice will be given to Buyer rather than the Contracting Officer.
- **52.211-15 Defense Priority and Allocation Requirements** (APR 2008). This clause is applicable if a priority rating is noted in this contract.

- **52.215-23 Limitations on Pass-Through Charges.** (JUN 2020). This clause applies if the contract is a cost-reimbursement contract that exceeds the simplified acquisition threshold, as defined in FAR 2.101 on the date of contract award. In paragraph (c), "Contracting Officer" shall mean Buyer.

In accordance with paragraph (d)(10)(vi), the following information is provided: (1) the prime contract number is _GS000Q14OADU108-47QFCA22F0047_, (2) Buyer's unique entity identifier is _D27FSZD2L2U9_, and the email address of Buyer's official responsible for acknowledging receipt of or rejecting ISRs is (contact Buyer's Authorized Procurement Representative.)
- **52.222-4 Contract Work Hours and Safety Standards-Overtime Compensation** (MAY 2018). Buyer may withhold or recover from Seller the amount of any sums the Contracting Officer withholds or recovers from Buyer because of liabilities of Seller or its subcontractors under this clause.
- **52.222-19 Child Labor Cooperation with Authorities and Remedies** (JAN 2018). In (d), "Contracting Officer" means Buyer.
- **52.222-21** Prohibition of Segregated Facilities (APR 2015).

- **52.222-26 Equal Opportunity** (SEP 2016).
- **52.222-27 Affirmative Action Compliance Requirements for Construction** (APR 2015). This clause applies only if this contract exceeds \$10,000.
- **52.222-35 Equal Opportunity for Veterans.** (JUN 2020). This clause applies if this contract is valued at or above the threshold specified in FAR 22.1303(a) on the date of subcontract award, unless exempted by rules, regulations or orders of the Secretary of Labor.
- **52.222-36 Equal Opportunity for Workers with Disabilities** (JUN 2020). This clause applies if this contract is in excess of the threshold specified in Federal Acquisition Regulation (FAR) 22.1408(a) on the date of contract award, unless exempted by rules, regulations, or orders of the Secretary.
- **52.222-37 Employment Reports on Veterans** (JUN 2020). This clause applies if this contract is valued at or above the threshold specified in FAR 22.1303(a) on the date of subcontract award, unless exempted by rules, regulations, or orders of the Secretary of Labor.
- **52.222-40** Notification of Employee Rights Under the National Labor Relations Act. (DEC 2010).
- **52.222-50 Combating Trafficking in Persons** (NOV 2021). The term "Contractor" shall mean "Seller", except in the paragraph (a) definition of Agent, and except when the term "prime contractor" appears, which shall remain unchanged. The term "Contracting Officer" shall mean "Contracting Officer, Buyer's Authorized Procurement Representative" in paragraph (d)(1). Paragraph (d)(2) shall read as follows: "If the allegation may be associated with more than one contract, the Seller shall inform the Buyer's Authorized Procurement Representative for each affected contract." The term "the Government" shall mean "the Government and Buyer" in paragraph (e). The term "termination" shall mean "Cancellation" and "Cancellation for Default", respectively, in paragraph (e)(6). The term "Contracting Officer" shall mean "Contracting Officer and Buyer" in paragraph (f), except in paragraph (f)(2), where it shall mean "Contracting Officer or Buyer". Paragraph (h)(2)(ii) shall read as follows: "To the nature and scope of the activities involved in the performance of a Government subcontract, including the number of non-United States citizens expected to be employed and the risk that the contract or subcontract will involve services or supplies susceptible to trafficking in persons." The term "Contracting Officer" shall mean "Contracting Officer or Buyer" in paragraph (h)(4)(ii). The term "Contracting Officer" shall mean "Buyer" in paragraph (h)(5).
- **52.222-54 Employment Eligibility Verification** (MAY 2022). - **52.225-19** Contractor Personnel in a Designated Operational Area or Supporting a Diplomatic or Consular Mission Outside the United States. (MAR 2008). - **52.227-11 Patent Rights -- Ownership by the Contractor** (MAY 2014). This clause applies only if this contract is for experimental, developmental, or research work and Seller is a small business firm or nonprofit organization. In this clause, "Contractor" means Contractor, references to the Government are not changed and the subcontractor has all rights and obligations of the Contractor in the clause.
- **52.227-14 Rights in Data--General** (MAY 2014). This clause applies only if data, as defined in paragraph (a) of the clause, will be produced, furnished, or acquired under this contract.
- 52.227-17 Rights in Data-Special Works (DEC 2007).
- **52.227-21** Technical Data Declaration, Revision, and Withholding of Payments-Major Systems (MAY 2014). The term "Contracting Officer" shall mean "Buyer." In paragraph (b) (2), the term "Government" shall mean "Buyer."
- **52.228-3 Workers' Compensation Insurance (Defense Base Act)** (JUL 2014). This clause applies if the Defense Base Act applies to this contract.
- 52.228-4 Workers' Compensation and War Hazard Insurance Overseas (APR 1984).
- **52.228-5 Insurance Work on a Government Installation** (JAN 1997). This clause applies to contracts that requires work on a Government installation. In paragraph (b) and (b)2, "Contracting Officer" shall mean "Buyer". In paragraph (c), "Contracting Officer" shall mean "Contracting Officer or Buyer". Seller shall provide and maintain insurance as set forth in this contract, which is GS00Q14OADU108-47QFCA22F0047.
- **52.232-40 Providing Accelerated Payments to Small Business Subcontractors.** (DEC 2013). This clause applies to contracts with small business concerns. The term "Contractor" retains its original meaning.
- **52.237-2 Protection of Government Buildings, Equipment, and Vegetation** (APR 1984). This clause applies only if work will be performed on a Government installation. "Contracting Officer" shall mean Buyer.
- **52.244-6 Subcontracts for Commercial Items** (AUG 2018). Clauses in paragraph (c) (1) apply when Seller is providing commercial items under the Contract.
- **52.245-1 Government Property** (JAN 2017). This clause applies if Government property is acquired or furnished for contract performance. "Government" shall mean Government throughout except the first time it appears in paragraph (g)(1) when "Government" shall mean the Government or the Buyer.
- **52.247-63 Preference for U.S.-Flag Air Carriers** (JUN 2003). This clause only applies if this contract involves international air transportation.
- 52.247-67 Submission of Transportation documents for Audit (FEB 2006). This clause applies if the

contract is a cost-reimbursement contract. Paragraph (a) (2) is deleted. Documents shall be submitted to Buyer as specified elsewhere in this contract.

- 52.248-1 Value Engineering (JUN 2020). This clause applies only if this contract is valued at or above the simplified acquisition threshold, as defined in FAR 2.101 on the date of subcontract award. The term "Contractor" means Seller. The term "Contracting Officer" means Buyer. The term "contracting office" means US Government contracting office. The term "Government" means Buyer except in subparagraph (c)(5). The term "Government" does not mean Buyer as it is used in the phrase "Government costs". Paragraph (d) shall read as follows: The Seller shall submit VECP's to the Buyer. Subparagraph (e)(1) shall read as follows: The Buyer will notify the Seller of the status of the VECP after receipt. The Buyer will process VECP's expeditiously; however, it will not be liable for any delay in acting upon a VECP. Paragraph (m) shall read as follows: (m) Data. The Seller may restrict the Government's right to use any part of a VECP or the supporting data by marking the following legend on the affected parts: These data, furnished under the Value Engineering clause of contract, shall not be disclosed outside the Buyer and Government or duplicated, used, or disclosed, in whole or in part, for any purpose other than to evaluate a value engineering change proposal submitted under the clause. This restriction does not limit the Buyer's and Government's right to use information contained in these data if it has been obtained or is otherwise available from the Seller or from another source without limitations. If a VECP is accepted, the Seller hereby grants the Government unlimited rights in the VECP and supporting data, except that, with respect to data qualifying and submitted as limited rights or Government purpose rights technical data, the Government shall have the rights specified in the contract modification implementing the VECP and Seller shall appropriately mark the data. (The terms "unlimited rights" a "limited rights" and "Government purpose rights" are defined in Part 27 of the Federal Acquisition Regulation ("FAR") or Part 227 of the Defense FAR Supplement, as applicable.) Seller's share of the net acquisition savings and collateral savings shall not reduce the Government's share of concurrent or future savings or collateral savings. Buyer's payments to Seller under this clause are conditioned upon Buyer's receipt of authorization for such payments from the Government
- **52.253-1 Computer Generated Forms** (JAN 1991).
- **52.225-1 Buy American-Supplies** (OCT 2022). The term "Contracting Officer" shall mean Buyer the first time it is used in paragraph (c). In paragraph (d), the phrase "in the provision of the solicitation entitled 'Buy American Certificate' is deleted and replaced with "in its offer."
- **52.246-6 Inspection-Time-and-Material and Labor-Hour** (MAY 2001).
- **2. DoD FAR Supplement Clauses** DoD Contracts. The following contract clauses are incorporated by reference from the Department of Defense Federal Acquisition Regulation Supplement and apply to the extent indicated. In all of the following clauses, "Contractor" and "Offeror" mean Seller except as otherwise noted.
 - **252.203-7001** Prohibition on Persons Convicted of Fraud or Other Defense-Contract-Related Felonies (DEC 2008). This clause applies only if this contract exceeds (i) \$100,000 if included in Buyer's customer RFP or customer contract issued before October 1, 2010 or (ii) \$150,000 if included in Buyer's customer RFP issued on or after October 1, 2010, or if the prime contract was issued prior to October 1, 2010 but was amended after October 1, 2010 to increase the Simplified Acquisition Threshold and is not for the purchase of commercial items or commercial components. Except in paragraph (a), "this contract" and "the contract" mean the contract between Buyer and Seller. In subparagraph (d)(2), delete the words "or first-tier subcontractor." In paragraph (e), the remedies described in subparagraphs (2) and (3) are available to Buyer, not the Government. In paragraph (f), "through the Buyer" is inserted after "Contracting Officer." Paragraph (g) is deleted.
 - **252.203-7002 REQUIREMENT TO INFORM EMPLOYEES OF WHISTLEBLOWER RIGHTS** (DEC 2022).
 - **252.203-7003 Agency Office of the Inspector General.** (DEC 2012). This clause applies if FAR 52.203-13 applies.
 - **252.203-7004 DISPLAY OF HOTLINE POSTER** (JAN 2023). The clause applies if the Contract exceeds the threshold specified in Defense Federal Acquisition Regulation Supplement 203.1004 (b)(2)(ii) on the date of Contract award, except if the contract is for the aquisition of a commercial product or commercial service.
 - **252.204-7000 Disclosure of Information** (OCT 2016). Seller shall submit requests for authorization to release information through Buyer. Seller shall submit written requests to Buyer a minimum of 25

days prior to proposed date of release.

252.204-7012 Safeguarding Covered Defense Information and Cyber Incident Reporting (DEC 2019). This clause applies if the Contract is for operationally critical support or where performance will involve a covered contractor information system. The term "contractor" retains its original meaning wherever the word is not capitalized. In the terms "Contractor attributional/proprietary information," "Contractor information system" and "covered contractor information system," the term "contractor" also retains its original meaning. In paragraphs (d) and (g), "Contracting Officer" shall mean "Contracting Officer or Buyer." In paragraph (m)(2), the term "prime Contractor" retains its original meaning. In accordance with paragraph (m)(2)(i), Seller shall notify Buyer when submitting a request to the Contracting Officer to vary from NIST SP 800-171. Reporting to Buyer in accordance with (m)(2)(ii) shall be accomplished via abuse@Boeing.com with a copy to the Buyer's Authorized Procurement Representative. The Boeing 1st tier subcontractor promptly shall report lower tier subcontractor information it receives.

Unless otherwise permitted herein, all Seller personnel and/or Seller subcontractor personnel proposed and/or assigned to the contract shall be US citizens. Seller shall notify Buyer immediately in writing of any proposed exceptions to this requirement.

AFGHANISTAN VISA AND BUSINESS LICENSE - RESERVED

Applies only if work will be done in Afghanistan in support of the United States Military Forces.

- A) In accordance with the Strategic Partnership Agreement between the Islamic Republic of Afghanistan and the United States, if Seller personnel will be working in Afghanistan, any, and all, access and exit from Afghanistan will require a VISA for all Seller personnel.

In such cases, the Seller, at its own expense, is responsible for providing and maintaining personnel with the appropriate security clearances to ensure compliance with Government security regulations, as specified in the individual task order.

The Seller shall fully cooperate on all security checks and investigations by furnishing requested information to verify the Seller's or Seller's subcontractor's employee's trustworthiness and suitability for the position.

The Buyer and Government have full and complete control over granting, denying, withholding or terminating security clearances for Seller or Seller subcontractor employees. The granting of a clearance shall not prevent, preclude, or bar the withdrawal or termination of any such clearance by the Government or Buyer.

HSPD-12

TRAINING AND PERMITS

The Seller shall provide fully trained and experienced personnel required for performance under this contract. The Seller shall train Seller personnel, at its own expense, except when the Buyer has given prior approval for specific training to meet special requirements that are peculiar to a particular contract requirement.

Except as otherwise provided in the contract, the Seller shall, at its own expense, be responsible for obtaining any and all licenses, certifications, authorizations, approvals, and permits, and for complying with any applicable Federal, national, state, and municipal laws, codes, and regulations, and any applicable foreign work permits, authorizations, and/or visas in connection with the performance of this contract.

ETHICS AND CONDUCT

Personal services are not authorized under this contract. This contract is strictly a non-personal services contract which means the personnel rendering the services are not subject, either by the contract's terms or by the manner of its administration, to the supervision and control usually prevailing in relationships between the Government and its employees or Buyer and its employees.

The Seller and its employees must conduct themselves with the highest degree of integrity and honesty and adhere to the policies and procedures as specified in FAR Part 3 and GSAM Part 503 Improper Business Practices and Personal Conflicts of Interest.

SUPERVISION

The Seller shall not supervise, direct, or control the activities of Government personnel or the employee of any other contractor under Buyer's or Buyer's customer's prime contract and the Government and Buyer will not exercise any supervision or control over the Seller in the performance of contractual services under the contract. The Seller is accountable to the Buyer and Government for the actions of its personnel.

Seller employees shall not represent themselves as Government or Buyer employees, agents, or representatives or state orally or in writing at any time that they are acting on behalf of the Government or Buyer.

In all communications with third parties in connection with the contract, the Seller must ensure that all Seller employees

If the Seller believes any action or communication has been given that would create a personal services relationship between the Government/Buyer and any Seller employee or any other potential supervision or duty violation, the Seller must notify the Buyer immediately of this communication or action.

CONDUCT

The Seller shall not discuss with unauthorized persons any information obtained in the performance of work under the contract; conduct business other than that which is covered by contract during periods funded by the Buyer/Government; conduct business not directly related to the contract on Government premises; use Government computer systems and/ or other Government facilities for company or personal business; recruit on Government premises; or otherwise act to disrupt official Government business.

The Seller shall ensure that all of its employees, including Seller subcontractor employees, working under the contract are informed of the substance of this clause.

If the Seller believes any action or communication has been given that would create a business ethic or conduct violation, the Seller must notify the Buyer immediately of this communication or action.

CONFLICTS OF INTEREST

All Seller personnel (to include Seller subcontractors and consultants) who will be personally and substantially involved in the performance of any task order issued under the Buyer's customer's prime contract which requires the Seller to act on behalf of or provide advice with respect to any phase of an Government agency procurement shall execute and submit an "Employee/Contractor Non-Disclosure Agreement" Form. The Government will provide the appropriate nondisclosure form specific to the procurement. This form shall be required prior to the commencement of any work and whenever replacement personnel are proposed.

The Seller shall be responsible for identifying and preventing personal conflicts of interest of their employees. The Seller shall prohibit employees who have access to non-public information by reason of performance on a Government contract from using that information for personal gain.

In the event that a contract requires activity that would create an actual or potential conflict of interest, the Seller shall immediately notify the Buyer of the conflict, submit a plan for mitigation, and not commence work until specifically notified by the Buyer to proceed; or, identify the conflict and recommend to the Buyer an alternate approach to avoid the conflict.

GOVERNMENT FACILITIES

A Seller working in a government facility shall be responsible for maintaining satisfactory standards of employee competency, conduct, appearance, and integrity and shall be responsible for taking disciplinary action with respect to their employees as necessary.

RIGHTS OF INGRESS AND EGRESS

The rights of ingress to, and egress from, Government facilities for the Seller's personnel must be specified in the contract. Specific federally-controlled facilities or those areas located within a given facility may have additional security

SECURITY CLEARANCES

All personnel requiring access to sensitive data and equipment shall have a TS clearance with eligibility for SCI prior to being assigned. For all Seller personnel assigned, SCI eligibility means the individual is eligible for immediate SCI nomination and indoctrination upon TOA and approval of the DoD Form 254 (DD254). All other personnel shall have the appropriate security clearance commensurate with their roles.

The Seller may have access to unclassified and classified data. For access to classified information, the Seller shall ensure that all personnel with access to classified information have the necessary security clearances. Seller personnel visiting any Government facility in conjunction with this contract shall be subject to the standards of conduct applicable to Government employees. Site-specific approval regarding access to sensitive materials, computer facility access, and issuance of security badges shall be coordinated with the appropriate POC, as required. All necessary facility and employee security clearances shall be at the expense of the Seller.

Neither the Seller nor any of its subcontractors shall publicly disclose any information concerning operations or military activities performed under this contract. Such action(s) would be a violation of the provisions of this contract and may also be a violation of public law and Federal regulations.

Where interoperable, DoD Public Key Infrastructure (PKI) or CACs are required for the exchange of unclassified information between DoD and its vendors and contractors or for access to Public Key-enabled information systems and websites, the Seller shall obtain all necessary certificates. The Government will support the issuing of CACs.

Seller and all associated Seller subcontractor employees shall provide all information required for background checks to meet installation access requirements to be accomplished by installation Provost Marshal Office, Director of Emergency Services or Security Office. The Seller workforce shall comply with all personal identity verification requirements (FAR clause 52.204-9, Personal Identity Verification of Contractor Personnel) as directed by DoD and/or local policy and regulations. If the Force Protection Condition (FPCON) at any individual facility or installation changes, the Government may require changes in contractor security matters or processes.

Before CAC issuance, the Seller employee requires, at a minimum, a favorably adjudicated National Agency Check with Law and Credit (NACLC) or its equivalent or higher investigation in accordance with DoD Manual 5200.02, Personnel Security Program. The Seller employee will be issued a CAC only if duties involve one of the following: (1) both physical access to a DoD facility and access, via logon, to DoD networks on-site or remotely; (2) remote access, via logon, to a DoD network using DoD-approved remote access procedures; or (3) physical access to multiple DoD facilities or multiple non-DoD Federally controlled facilities on behalf of the DoD on a recurring basis for a period of six months or more. At the discretion of the sponsoring activity, an initial CAC may be issued based on a favorable review of the Federal Bureau of Investigations (FBI) fingerprint check and a successfully scheduled NACLC at the Office of Personnel Management (OPM).

For Sellers that do not require CAC but require access to a DoD facility or installation, the Seller and all associated Seller subcontractor employees shall comply with adjudication standards and procedures using the National Crime Information Center Interstate Identification Index (NCIC-III) and Terrorist Screening Database (TSDB), applicable installation, facility and area commander installation/facility access, and local security policies and procedures or at OCONUS locations, in accordance with Status of Forces Agreements (SOFAs) and other theater regulations.

Seller personnel not requiring a personnel security clearance but performing Automated Data Processing (ADP) sensitive duties are subject to investigative and assignment requirements in accordance with DoD 5200.2R, DoD Personnel Security Program, and affiliated regulations. The Seller shall bear the cost of any security clearances required for performance. The Seller shall provide escort for uncleared personnel.

The Buyer or Government will be responsible for obtaining security certification for all equipment/systems processing classified information. All security requirements for this task are defined in the contract.

THEATER RISK ASSESSMENT AND MITIGATION

If a Seller employee departs an area of operations without Seller permission, the Seller shall ensure continued performance in accordance with the terms and conditions of the contract. If the Seller replaces an employee who departs without permission, the replacement is at Seller expense and must be in place within two business weeks or as directed by the Buyer.

For badging and access purposes, the Seller shall provide the Buyer, FEDSIM CO or COR a list of all Seller employees (including qualified Seller subcontractors and/or local vendors being used in the area of operations) with all required identification and documentation information.

The Seller contractor shall brief its employees regarding the potential danger, stress, physical hardships, and field living conditions. The Seller shall require all of its employees to acknowledge in writing that they understand the danger, stress, physical hardships, and field living conditions that are possible if the Seller employee deploys in support of military operations.

The Seller shall designate a POC for all of its plans and operations and establish an operations center to plan and control the contractor deployment process and resolve operational issues with the deployed force.

ORGANIZATIONAL CONFLICT OF INTEREST AND NON-DISCLOSURE REQUIREMENTS

1. ORGANIZATIONAL CONFLICT OF INTEREST (OCI)

If a Seller has performed, is currently performing work, or anticipates performing work that creates or represents an actual or potential OCI, the Seller shall immediately disclose this actual or potential OCI to the FEDSIM CO, via the Buyer, in accordance with FAR Subpart 9.5. The nature of the OCI may involve the prime contractor, Buyer, subcontractors of any tier, or teaming partners.

2. NON-DISCLOSURE REQUIREMENTS

If the Seller acts on behalf of, or provides advice with respect to any phase of an agency procurement, as defined in FAR 3.104-4, then the Seller shall execute and submit a Corporate Non-Disclosure Agreement (NDA) Form and ensure that all its personnel (including Seller subcontractors, teaming partners, and consultants) who will be personally and substantially involved in the performance of the contract:

- a. Are instructed in the FAR 3.104 requirements for disclosure, protection, and marking of contractor bid or proposal information, or source selection information.
- b. Are instructed in FAR Part 9 for third-party disclosures when acting in an advisory capacity.

All proposed replacement Seller personnel shall also be instructed in the requirements of FAR 3.104. Any information provided by contractors in the performance of this contract or obtained from the Government is only to be used in the performance of the contract. The Seller shall put in place appropriate procedures for the protection of such information and shall be liable to the Buyer and/or Government for any misuse or unauthorized disclosure of such information by its personnel, as defined above.

MITIGATION

At any time during the performance of the contract if an actual, potential, or apparent COI is identified whether by the CO,

It is the Seller's responsibility under the terms and conditions to provide timely notification to the Buyer those COIs that are self-identified. The Government and/or Buyer will review the submission at which time a determination will be made whether a COI has been satisfactorily mitigated or if further action is necessary and will notify the contractor accordingly.

During the course of providing Services ("Services") under the contract, Seller may obtain, access or otherwise Process information that identifies an individual or relates to an identifiable individual ("Personal Information") living or working in the European Union from, or on behalf of the Buyer, Prime Contractor and its affiliates. Seller agrees to protect all such Personal Information as detailed below.

DATA PROCESSING AND PROTECTION

- 1.1. Compliance with Law. Seller will comply with all applicable laws relating to the protection of Personal Information that apply with respect to Seller handling of Personal Information under Regulation (EU) 2016/679, the General Data Protection Regulation (the "GDPR")
- 1.2 Subcontracting. Seller will not disclose or transfer Personal Information covered by the GDPR to, or allow access to Personal Information by (each, a "Disclosure") any third party without Buyer's express prior written consent; provided, however, that Seller may Disclose Personal Information to its affiliates and subcontractors for purposes of providing the Services to Buyer or the Prime Contractor, subject to the following conditions: (a) Seller will maintain a list of the affiliates and lower-tier subcontractors to which it makes such Disclosures and will provide this list to Buyer upon Buyer's request; (b) Seller will provide Buyer at least [30 days'] prior notice of the addition of any affiliate or subcontractor to this list and the opportunity to object to such addition(s); and (c) if Buyer or Prime Contractor makes such an objection on reasonable grounds and Seller is unable to modify the Services to prevent Disclosure of Personal Information to the additional affiliate or subcontractor, Buyer or Prime Contractor will have the right to terminate the relevant Processing. Seller will, prior to any Disclosure, enter into an agreement with such third party that is at least as restrictive as this Attachment. Such agreement will be provided to Prime Contractor promptly upon request. Subcontractor will be liable for all actions by such third parties with respect to the Disclosure.
