D. NON-DISCLOSURE AGREEMENTS

The Trade Secrets Act, 18 U.S.C. § 1905, prohibits Government employees from making unauthorized disclosures of Seller's or subcontractor's proprietary information. Government employees shall not be required to sign a non-disclosure agreement or any other document, or to furnish personnel or biographical information or documents, as a condition to gaining access to Seller's or subcontractor's data or other information needed to perform their official duties. The Seller shall include, an ensure inclusion of, this clause, suitably modified to identify the parties, in all subcontractors at all tiers.
