In the event an offeror determines that one or more parts involved in the manufacture of the item reflected in Section B become either obsolete or nonprocurable, the offeror shall provide written notice to the Buyer. This notice will include the offeror's recommendation to correct the problem and should be one of the following general categories:

- a. Alternate Sources Within Industry
- b. Part redesign

Included within the recommendation will be the offeror's assessment of any proposed price and delivery schedule impacts associated with the recommendation.

Upon receipt of the notification, Buyer will determine the appropriate course of action and give written direction to the Contractor.

Re-design or Vendor qualification effort undertaken by the Contractor to implement Buyer's direction may be the basis of a request for an equitable adjustment.

No alternate action to the requirements of this contract are to be taken by the Contractor without the written approval/direction of the Buyer.
