CONDUCT OF CONTRACTOR PERSONNEL (MAR 2001)

If the PCO determines it to be in the best interest of the Government within the foreign environment in which the Contractor will be operating outside the limits of the United States and its possessions, he may at any time during the performance of this contract, order the Contractor to remove any of its personnel from further performance under this contract for reasons of security or violation of laws ore regulations. Contractor employees may also be removed at the request of the host country. In the event it becomes necessary to remove any Contractor employee for any of the above reasons, and if not caused by the negligence of the Contractor, the costs associated with such removal, including the costs or replacement of any personnel so removed, will be subject to an equitable adjustment.
