**GOVERNMENT PROVISIONS
APPLICABLE TO
PRIME CONTRACT L/C DAAH01-99-C-0052**

The clauses contained in the following Government regulations are incorporated by reference. - 52.215-14 Integrity of Unit Prices (Excluding paragraph (b)). (Not applicable if only services will be provided.)
- 52.222-4 Contract Work Hours and Safety Standards Act - Overtime Compensation
- 52.223-2 Clean Air and Water (Also applicable if Seller's facility has been the subject of a conviction under the Clean Air Act or Federal Water Pollution Control Act.)
- 52.227-2 Notice and Assistance Regarding Patent and Copyright Infringement. ("Contracting Officer" means Buyer.)
- 252.203-7001 Special Prohibition on Employment
